The special meeting has been called to discuss the purchase of a used dump truck w/ snow plows, box and sander. The Town of Castile has a 2016 Peterbilt they are asking \$150,000.00

There is a concern when buying used equipment as there is no warranties, however, the Sterling that the town currently owns is in desperate need of replacement. The 2007 Sterling will not be in service next year. The purchase of a new dump truck would mean that the town would wait at least 2 years to receive the new truck. The Town cannot be without a third truck that long.

Community Bank offered a loan at a fixed rate of $5.29 \%$ that would need to be bonded. The bond could be written by the town attorney. At this time it is unknown if Mr Degnan could or would write that bond or what his fee for doing so would be.

KS State Bank offers a loan at $6.49 \%$ for a three year loan, $6.550 \%$ for a four year loan or 6.59\% for a five year loan. No bond needed.

There is no way to purchase the vehicle outright. The Board will need to make the down payment out of the fund balance and then budget for the subsequent payments.
